1. I (releaser) agree, because of the many hazards of the Island, latent or patent, I do hereby release, discharge, and hold harmless The Islands, LLC, NOCO Islands, LLC Jensen Recreation Corporation and Jensen Investments LLC, its principals, officers, and its employees from any and all liability for any type of injuries (including death) I or my children may suffer as a result of the use of these facilities. This Release and Waiver of Liability shall be binding on my heirs, executors, administrators, successors, and assigns.
2. I understand that by signing this unconditional release, as an adult, it also bars any claim that may occur on behalf of my children.
3. I understand that I or my children will be transported to Island event by boat and upon embarking the boat will **remain seated at all times** until the boat is docked and ready to disembark.
4. I agree that NOCO Islands and its employees are **not responsible for any lost, damaged, or stolen items including vehicles parked for events.**
5. I confirm I have read the **Island Rules** and **agree to obey all rules** and agree to my ejection if I violate any of these rules, I will explain rules to any children that are part of my group.
6. I agree (my children as well), **must wear a Personal Floatation Device (PFD) when engaging in any water activities. I understand that there is no lifeguard on duty. (NO EXCEPTIONS)**
7. That I will **NOT bring any glass containers onto Island, liquor, paraphernalia or drugs** and understand if I do so it will be confiscated, and I will be required to leave. I understand that this is private property and consent to bags, totes, coolers, etc. to be searched if probable cause, that I have the right to refuse search but will be required to leave premise.
8. I understand I **must have a valid ID and be 21 years of age to drink alcoholic beverages** and will not allow underage children to drink alcohol. It is my responsibility to drink responsibly and be responsible for my children's actions. By signing this waiver, I agree that the above-named parties **will under no circumstance be held liable for any accidents due to intoxicated or inappropriate behavior.** This applies to all individuals during and immediately after the event.
9. I have read and signed this Release knowingly, voluntarily (and at a time I am competent, and not under the influence of alcohol or drugs), because I want to use the Island facilities and the related facilities and accept all risk of such use.
